



ACTIVE WORKPLACE CERTIFICATION

Company sport: all types of sports and physical activities organised with, by or within the workplace (*sport incentives and team-building events, participation in sport tournaments, conferences with high-level athletes...*).

Workplace: Any location where the organisation performs its operational functions. These include SMEs, local authorities, associations, liberal professions, self-employment structures with at least one staff member or employee.

WAC PROJECT - BACKGROUND

A Durable, Reliable & Credible WAC certification programme

Co-funded by **the Erasmus+ Programme of the European Commission**, WAC - Workplace Active Certification - was a three-years European project that started in 2020 and was led by the **European Federation for Company Sport (EFCS)**. It intends to set up, test and launch a certification process in order to value and reward professional organisations implementing physical activity for their employees.

- **To determine relevant actions to be taken in order** to improve the existing committed initiatives,
- **To assess and reward** the company's commitment to **well-being** in the workplace,
- To improve services for the **employees' well-being** and for the quality of life in the workplace,
- To strengthen your **employer brand** and to promote your **company's image** by implementing sports policies for improved team cohesion.



HOW DOES IT WORK?

Introductory questionnaire:

Open: May 22th, 2023

First online self-analysis of existing programmes of the organisation and other administrative elements..

Submission of the completed 22 criteria on the digital platform:

Second online self-analysis, to provide evidence and answers by uploading documents, reports, pictures, videos, etc. .

3

External & internal evaluation:

June 1st - October 20th, 2023

Interaction between the company and the certification commission and carrying out of remote audits. After the meeting, the certification commission will send a report with their conclusions.

4

Certification:

Week of November 20th, 2023

Valid for 3 years. Annual updates about your progress supported by tangible evidence must be provided. A rewards ceremony will be organised in Brussels.
